WARNING! All recipients of this Market Action Notice must read, understand and follow all instructions carefully.

Dear Honeywell Respiratory Protection Customer,

At Honeywell, our mission is to be the global leader in personal protective equipment with innovative solutions that help protect workers and workplaces. Aligned with this commitment, Honeywell issued a Mandatory Stop Use Notice on or about December 22, 2022, related to Powered Air Purifying Respirator (PAPR) Cartridges SKUs **PA7DEHE** and **PA7OVAGHE** (guidance on identifying the applicable cartridges found in Addendum A to this Notice). At that time, Honeywell notified customers of a quality issue that could cause possible exposure to carbon and other substances, creating a potential safety issue for the user.

As these PAPR Cartridges do not meet Honeywell's high standards, we are replacing all unopened, unused products produced before November 2022.

REPLACEMENT PROCESS:

- Confirm purchase of affected product by the Model and Lot Number found in Addendum A.
- For any unopened, unused cartridges, please fill out the attached Honeywell PAPR Cartridges Replacement Order Form along with the Certification found at Addendum B to this Notice. Honeywell requests that your respond within the next 90 days in order to provide timely replacement of cartridges
- Upon receipt of proper documentation and verification by Honeywell, Honeywell will issue replacement products.
- After confirming model and lot number, dispose all applicable cartridges, including unopened and opened/used cartridges, in accordance with local regulations and guidelines.

Honeywell regrets any inconvenience this issue has caused. Honeywell remains committed to worker safety, and we felt it was necessary and prudent to take these actions.


